

ALONG WITH A PASSPORT APPLICATION, WHAT WILL I NEED?

AGE OF APPLICANT AND TYPE OF SERVICE	<u>BIRTH CERTIFICATE</u> (ORIGINAL OR CERTIFIED COPY + A PHOTOCOPY B.C. <u>MUST</u> SHOW BOTH PARENTS NAMES) IF A PREVIOUS U.S. PASSPORT HAS BEEN ISSUED, IT <u>MUST</u> BE SUBMITTED. IF APPLICANT IS 16 YRS. OLD OR OLDER, OLD U.S. PASSPORT MAY BE USED IN LIEU OF BIRTH CERTIFICATE. - Applicant MUST appear in person when the application is presented for processing, regardless of age.
- Passport Services strongly advises that a separate check or money order for any fees payable to the Department of State is included for each individual application.
- When applicant is 15 years of age or younger they must be accompanied by both parents at the time application is presented. *If one parent is not able to be present, they may complete and submit a "Statement of Consent or Special Circumstances" (Form DS-3053) with the applicant's application AND a copy (front & back) of the absent parents photo ID (i.e. driver license).*
- If applicant is a minor & mother's last name has changed (possibly due to remarriage) a certified copy of the document changing the name (i.e. marriage certificate) MUST be submitted.
- Adopted Children: Certified copies of Adoption Decree are required. Applicants born on or after 2/23/83 & claiming citizenship through Foreign Adoption must submit the Certified copy of Adoption Decree (with translation) & evidence of lawful admission to the US such as alien registration card or foreign passport with entry Visa. Other documents may be required.
- Applicants ages 16 and 17 may apply without a parent IF they present a letter of permission from the parent OR they pay the passport fee to the U.S. Department of State with a check bearing the parent's name and signature.
- Passport cards are only good for land travel to Canada & Mexico & some cruises (not all). Passport cards will be returned by first-class mail.
- Applications MUST be completed with BLACK ink or type-written. Do NOT sign application until instructed to do so. Do NOT attach your photo.
