SPECIFIC FORMS ARE NECESSARY FOR NOTIFICATION.</i></p> <p><b>IF ASBESTOS IS PRESENT IN THE BUILDING, IT SHOULD BE ADDRESSED BEFORE THE DEMOLITION. OFTEN TIMES, ASBESTOS MUST BE REMOVED BY A GEORGIA LICENSED ASBESTOS CONTRACTOR BEFORE DEMOLITION BEGINS. IF ASBESTOS IS PRESENT AND THE DEMOLITION CONTINUES, THE OWNER OF THE BUILDING AND THE DEMOLITION CONTRACTOR CARRY EQUAL RESPONSIBILITY IF ASBESTOS IS DISTURBED.</b></p> <p><b>ANY OF THE FOLLOWING E.P.D.
