After discussion, Mark Goddard motioned to amend the definition as follows.

A "Local Recreation Provider" is defined as an organization registered as a nonprofit corporation with the Georgia Secretary of State's Office with a separate local Cherokee County governing board and by-laws for the primary purpose of providing and delivering recreation opportunities to the citizens of Cherokee County whether or not a fee is charged...

The rest of the definition would remain unchanged. Amy Turcotte seconded the motion. The motion carried 5-0.

i. Consideration of Volunteer Handbook

The volunteer handbook was presented to the Advisory Board for their consideration. Director Reynolds went over the handbook describing the policies and procedures contained within. Amy Turcotte motioned to recommend approval of the Volunteer Handbook to the Board of Commissioners. Vice Chairman Goddard seconded the motion. The motion was approved 5-0.

ii. Consideration of Sign & Landscape Proposal by Towne Lake HOA for Hobgood Park

Douglas Frasier with the Towne Lake ROA contacted Director Reynolds about replacing the existing Towne Lake sign at the intersection of Towne Lake Parkway and Bells Ferry Road in front of Hobgood Park. Director Reynolds described the requests for a sign easement and landscape easement along both the Towne Lake and Bells Ferry frontage for the park. He stated that the

costs of installing and maintaining the new sign and landscaping would be covered by the Towne Lake ROA and that the new sign and landscaping would not affect the public's use of the park in any way because both are located well away from public amenities. Chairman Hampton motioned to recommend approval of the Sign & Landscape proposal by Towne Lake ROA for Hobgood Park to the Board of Commissioners and Mark Goddard seconded the motion. The motion was approved 5-0.

Amy Turcotte made a suggestion to the board to consider naming a park or ball field in memory of Collins Dixon. He was a very active young man that lost his battle to cancer. There was a discussion on Collins, and it was suggested that the board do research on some of the sports and locations where he played.
