ADOPTION STANDING ORDER

At the time of filing a Petition for Adoption with the Clerk of Superior Court, the Petitioner(s) is (are) responsible for providing a copy of the Petition for Adoption to the staff of the assigned Judge, including a blank Rule Nisi for the Judge's signature.

Pursuant to O.C.G.A. § 19-8-16, each Petitioner in any agency (O.C.G.A. § 19-8-4), third-party (O.C.G.A. § 19-8-5), stepparent (O.C.G.A. § 19-8-6), or relative (O.C.G.A. § 19-8-7) adoption shall submit to and complete a fingerprint-based criminal background check by both the National Crime Information Center (NCIC) and Georgia Crime Information Center (GCIC) and shall cause the results to be submitted electronically to the assigned Judge's office. However, in the event a Petitioner for third-party adoption under O.C.G.A. § 19-8-5 has submitted to criminal background checks within the 12 months immediately preceding the filing of the Petition for the purpose of completing the home study, and whose results have been included in the home study report, and which home study report has been made available to the Court, that Petitioner shall not be required to submit to a new background check.

In each case in which a new fingerprint-based criminal background check is required, the background check shall be conducted as provided by law at a Georgia Applicant Processing Service (GAPS) location using a 3M Cogent Livescan machine. Per updated GAPS policy as of September 1, 2020, the Petitioners shall register online at https://www.aps.gemalto.com/ga/index.htm prior to going to the physical fingerprinting location. The staff of the assigned Judge must approve the Petitioner(s) in the GAPS system before the Petitioner(s) can have his/her fingerprinting completed.

The Petitioner(s) shall designate the Blue Ridge Judicial Circuit as the recipient of the background check results using the ORI number assigned to the Blue Ridge Judicial Circuit for adoptions. Upon receipt of the results of a background check, the Judge will review the results *in camera* and the Judge WILL NOT file a copy of the results upon the case record.

In Petitions for the domestication of foreign adoption decrees (O.C.G.A. § 19-8-8) and in adult adoptions (O.C.G.A. § 19-8-21), no criminal background check shall be required.

All inspections, investigations, home studies, evaluations, background checks, and verifications of the allegations contained in any Petition for Adoption shall comply with the provisions of Title 19, Chapter 8, of the Official Code of Georgia.
