All Petitions for Early Termination of Probation (hereinafter referred to as the "Petition") shall be filed with the Clerk of Court. The Petition shall contain a Certificate of Service, indicating that the probation office has served a copy of the Petition on the District Attorney's Office. Further, a courtesy copy of the Petition and a separate proposed Order for the signature of the assigned judge shall be provided to the assigned judge's office for review and signature either after a hearing, or after review, if no hearing is requested. The forms described are attached herein.

The District Attorney's Office shall have thirty (30) days from the date on the Certificate of Service to request a hearing on any Petition. If a Petition is filed under O.C.G.A. §42-8-37(d); and no hearing has been requested by by the District Attorney's Office within 30 days, the Court shall consider and rule on the Petition ninety (90) days after the filing of the Petition. If a Petition is filed under O.C.G.A. §17-10-1(A)(1)(b), and no hearing has been requested by the District Attorney's Office within 30 days, the Court shall consider and rule on the Petition any time after the 30 days has passed.
