**MISDEMEANOR BOND ORDER/SCHEDULE**

Pursuant to O.C.G.A. § 17-6-1(f)(1), the Court establishes a schedule of bonds for misdemeanor offenses in Cherokee County, Georgia. This Bond Schedule, effective July 5, 2018, shall supersede all previously issued bond orders and schedules. It is created to reflect recent changes to Georgia law effective July 1, 2018, concerning bonds in misdemeanor cases. The users of this list should keep in mind that it will not answer all questions as to bond and fine on every possible offense. The bond amounts listed do not include all statutorily mandated surcharges.

Any person charged with an offense listed on this schedule may be released by the Sheriff or his Deputies without first being brought before a judge if that person posts bond in the amount shown on the schedule. Persons unable to post bond shall be brought before a judge of a court of inquiry within 48 hours after a warrantless arrest, or 72 hours after an arrest with a warrant. The judge shall consider whether any bond reduction, including release on own recognizance, is appropriate, and whether any additional conditions of release are appropriate.

This court further establishes a schedule of no contest cash bonds/fines for the below offenses. These bond/fine amounts may be received by the clerk of Court prior to the actual court date of the defendant. "**SEE JUDGE**" offenses require the defendant to appear in court. This schedule of bond/fine amounts will be effective upon signature by the chief judge. If there is no amount listed in the **BOND** column, then the amount in the **FINE** column is the bond amount. "**SEE JUDGE**" offenses must post bond and cannot pay a fine prior to coming to Court.

**For the purpose of determining the amount to be assessed according to this schedule when the amount is based on number of offenses, an offense refers to a conviction (not a charge).**

Bonds for F.T.A. are double the normal bond for the given offense.

For any offense involving accidents, Defendants must "**See Judge**", to allow the Solicitor-General to contact victims prior to disposition of the case.

For offenses involving an act of family violence, as defined in O.C.G.A. § 19-13-1, the bail or other release from custody shall be set by a Judge on an individual basis and shall include a listing of specific conditions of bond.

\*\*For violations of O.C.G.A. §§ 16-5-90, 16-5-95, 16-12-100(c), 16-12-100.1, and 16-12-100.2(d)(2), each marked with a \*\* below, the fine shall be \$1500.00 plus surcharges and special conditions of bond shall be required in ALL cases.


