**MISDEMEANOR TRAFFIC AND GAME/FISH OFFENSE SCHEDULE**  
**FOR DURATION OF JUDICIAL EMERGENCY**

On March 13, 2020, Chief Superior Court Judge Ellen McElyea, in conjunction with Chief Justice Harold Melton's March 14, 2020 declaration of a statewide Judicial Emergency, declared a State of Judicial Emergency for the Blue Ridge Judicial Circuit. Under the "Order Declaring Statewide Judicial Emergency" issued by Chief Justice Melton, the emergency continues until 11:59 PM on April 13, 2020, but can be extended upon further order.

Therefore, pursuant to O.C.G.A. § 17-6-1(f)(1), Chief Judge W. Alan Jordan of the State Court of Cherokee County hereby establishes an Emergency Schedule of Fines for misdemeanor traffic and game and fish offenses in the State Court of Cherokee County, Georgia. **This Emergency Schedule DOES NOT affect or control the schedule of non-traffic misdemeanor no contest cash bonds/fines, which are still controlled by the "Misdemeanor Bond Order/Schedule" adopted by the Court on July 5, 2018.**

The fines established herein shall supersede the misdemeanor traffic and game and fish offenses fines created by the Court's "Misdemeanor Bond Order/Schedule" adopted on July 5, 2018. **However, this Fine Schedule shall only remain effective for 90 days or until the State of Judicial Emergency terminates, whichever is later in time. Upon the termination of the State of Emergency, the July 5, 2018 "Misdemeanor Bond Order/Schedule" shall be reinstated with full force and effect.** This order reduces the fines of payable offenses by 15% while it remains in effect, and the Clerk of State Court is hereby ordered to modify her internal procedures so as to effectuate the indicated fine reductions.

The fine amounts established herein may be received by the clerk of Court prior to the actual court date of the defendant, and the clerk is encouraged to facilitate such payments by all reasonable means. **"SEE JUDGE" offenses must post bond and cannot pay a fine prior to coming to Court.**

For the purpose of determining the amount to be assessed according to this schedule when the amount is based on number of offenses, an offense refers to a conviction (not a charge).

For any traffic offense involving an accident without injury (i.e., property damage *only*) for which a Uniform Traffic Citation (or Citations) was issued and which *will not* result in a suspension of the Defendant's drivers' license upon a plea of guilty, the requirement that such Defendants must **"SEE JUDGE," is suspended while this Emergency Schedule is in effect. In such cases, the Clerk is directed to allow online payments as with other traffic offenses, and to apply the 15% fine reduction available for other traffic offenses.**


