ORDER TO FILE UNCERTIFIED TRANSCRIPTS

The Court, through its Court Administrator, is in possession of certain uncertified transcripts of criminal proceedings held in this Circuit. A list of these transcripts and their corresponding case numbers is attached hereto as Exhibit "A", (hereinafter, "the transcripts").

The transcripts were prepared based on prior rules and orders governing the official court reporters of this Circuit. In 2013, the undersigned judge's official court reporter was investigated and charged with criminal offenses related to submitting fraudulent invoices to Cherokee County, as the governing authority responsible for compensating the court reporters. The allegations of the investigation were that the court reporter invoices were "padded" by several different means.

In the course of law enforcement's investigation of these court reporters, the transcripts were seized as evidence. The Court Administrator received these transcripts from law enforcement.

The filing of the transcripts would satisfy the rules and orders of this Court in place at the time of their preparation and perfect the record in those cases. Nothing herein shall prohibit any party from challenging the accuracy of a transcript pursuant to O.C.G.A. Section 5-6-41.

Therefore, the Court ORDERS that the Court Administrator file the transcripts, in either paper or digital format, as specified by the Clerk of Court, and that a copy of this Order also be filed in any case where any transcript named on Exhibit "A".
