We, the May 2017 Grand Jury, were informed about CodeRED, the web-based critical communication solution used in Cherokee County that enables local public safety personnel to notify residents and businesses by telephone, text message, email, and social media of time-sensitive information, emergencies or urgent notifications. This system can reach hundreds of thousands of individuals in minutes to ensure information such as evacuation notices, inclement weather advisories, missing persons, and more are quickly shared. Citizens can register free of charge by simply signing up on the enrollment website and selecting the preferred means of communication.
