We, the members of the September 2018 Term Grand Jury, received a complaint from the Clerk of Superior Court on September 11, 2018, that was filed by Lee Wynn alleging Board of Equalization (BOE) member Ben Cunningham could not be fair and impartial since he was a personal friend of Chief Tax Appraiser, Steve Swindell. We, the Grand Jury, interviewed the complainant and the Clerk of Superior Court and discovered that Ben Cunningham was appointed to serve on the BOE by the September 2017 Term Grand Jury, he has just recently finished his required training, but he has not yet sat on any appeal hearings.

After conducting an investigation, we, the Grand Jury, find there is insufficient evidence that BOE member Ben Cunningham is technically incompetent, has violated any state law or regulation, or has acted rude or unprofessionally toward any member of the public. Therefore, we, the Grand Jury, recommend that Ben Cunningham immediately be allowed to participate in appeals hearings.
