INSTRUCTIONS FOR OBTAINING A ZONING CERTIFICATION

The Cherokee County Planning & Zoning Department will certify the zoning of a property located in the unincorporated area of Cherokee County by using the following procedures.

Please provide the following items:

- 1. A signed and completed Request for Zoning Certification application form.
- 2. A legible boundary survey of the property <u>no larger than 11x17</u>. The surveyors stamp, title block and metes and bounds must be legible. The survey must show the boundary lines for the property for which the request is being made. The survey will become an exhibit in the Zoning Certificate.
- 3. A typed legal description (metes and bounds) of the property. The legal description will become an exhibit in the Zoning Certificate.
- 4. Check in the amount of \$ 50.00 made payable to <u>Cherokee County.</u> Payment may be made by cash or credit card <u>only</u> if brought in person to our offices in Canton, Georgia.

Our office will provide a letter certifying zoning of the property and conditions of zoning, if applicable. Please refer to the Zoning Ordinance, Table 7.2 – Permitted Uses Table for a list of permitted uses by zoning districts.

The zoning certification letter will NOT address:

- Whether a particular use is or would be permitted in the district.
- Whether a use on the property is or was considered a Non-Conforming Use.
- Whether buildings, structures or uses in the past or currently on the property are or were in compliance with zoning, development, building or any other regulation past or present.
- Zoning Staff will not fill out form letters or make statements about proper usage or if the property is a non-conforming use.

Please allow up to 10 business days for processing, not including delivery time.

Please be advised the Zoning Division does not certify conformance with the standards contained in the Zoning Ordinance and/or the Development Regulations, or confirm conformance with building codes, fire codes, sewer or water ordinances.
