Cherokee County Planning Commission Public Hearing Agenda January 6, 2009 7:00 PM

CASE #09-01-001 - Dr. L. Austin Flint requesting to rezone 5.68 acres from R-40 to GC for retail purposes. Property is located just east of the intersection of Cumming Highway and Key Drive in Land Lot 267 of the 14th District, 2nd Section and being more particularly described as Cherokee County Tax Map 14N23C, Parcel 37B.

CASE #09-01-002 - Dr. L. Austin Flint requesting to rezone 6.749 acres from R-40 to GC for retail purposes. Property is located at just west of the intersection of Cumming Highway and Key Drive in Land Lot 267 of the 14th District, 2nd Section and being more particularly described as Cherokee County Tax Map 14N23, Parcel 34.
