# 1. Case #17-12-045 Collett Family, LLC. (BOC Dist. 1)

Applicant is requesting to rezone 79.24 acres at 300 Collett Drive from AG to R-30 for a residential community utilizing conservation subdivision design.

Ms. Taylor Lee introduced and presented the case. Mr. Chapman gave the Community Agenda Report. General discussion and comments ensued. Rick Whiteside made a motion to deem the application incomplete. The motion was seconded by Mr. Ware, approved 9-0.

## 2. Case #17-03-006 Oak Hall Companions (BOC Dist. 2)

Applicant is requesting to rezone 39.575 acres at Arnold Mill Road and Highway 140 from AG to NC, RTH, and RZL Hill Road from AG to R-40 for residential uses.

Ms. Taylor Lee introduced the case and gave the staff reports. Mr. Chapman gave the Community Agenda Report. General discussion and comments ensued. Rick Whiteside made a motion to deem the application incomplete. The motion was seconded by Mr. Weatherby, approved 9-0.

#### 3. Case #17-04-013 R. Venture (BOC Dist. 1)

Applicant is requesting to rezone 54.61 +/- acres at Jessie Lane, Owens Store Road and Old Orange Mill Road from AG to R-20 for a single family residential subdivision
