
# CHEROKEE COUNTY EMERGENCY MANAGEMENT AGENCY EMERGENCY OPERATIONS CENTER

#### **DAILY UPDATE**

- Cherokee County EMA and Board of Commissioners ask that you be mindful of your needed travels, contact with others, continue to practice social distancing, and practice good hygiene.
- The Georgia Department of Public Health has announced 903,423confirmed cases of COVID-19 across the state.
- 18,496 deaths have occurred in the state as a result of COVID-19.
- Cherokee County has 22,874 confirmed cases of COVID-19, since March 8, 2020. This is an increase of 31 cases from June 26<sup>th</sup> to June 28<sup>th</sup>.
- Cherokee County has three hundred and eighteen (318) confirmed fatalities due to COVID-19.



# \*\*\* COVID-19 Vaccination Clinic Location\*\*\*

- The COVID-19 vaccination clinics are located at the Public Health Department centers in Canton and Woodstock. To make an appointment, please call the Canton Public Health Center (1219 Univerent Road, Canton, GA) at 770-345-7371 or the Woodstock Public Health Center (7545 North Main Street, Woodstock, GA) at 770-329-0133.
  - o ALL Georgian's aged 12 and older are eligible for the vaccine.

- Every Tuesday, Georgia Public Health will offer a Family Night COVID-19 Vaccine Clinic at the Canton Health Department location. The address is 1219 Univeter Road, Canton, GA, 30115. Hours for this event will be 4:00 pm until 6:00 pm. No appointment is needed.

## \*\*\*NEW COVID-19 drive-thru testing location\*\*\*

- COVID-19 testing is moving to a new location beginning July 1<sup>st</sup>. The new drive-thru testing site is located in the parking lot of Action Church (271 Marietta Road, Canton, GA, 30114). Hours of operations and pre-registration processes are listed below:
  - o Days/Hours of Operation: Monday-Friday from 8:00 AM until 3:00 PM
  - o It is highly recommended that you pre-register for your test at the following link https://mako.exchange/splash/GAmakotesting/
  - o Please do not call the church or enter the church buildings.

## **PREVENTATIVE MEASURES**
